<b>Location of Post</b>	The initial vacancy is in National Inter Agency Prevention Programme (NIAPP), operated by Tusla at our Cork office.  The post holder will initially be based at the NIAPP Office located at Floor 2, Unit 9, St Stephen's Hospital, Glanmire, Cork. This is a national NIAPP post and due to the nature of the post will involve work in multiple locations as required. Primary work will include Coordination of NIAPP Cork and NIAPP Kerry services; as well as weekly provision of NIAPP services in Limerick for an integrated specialist residential programme. <b>Details of Service</b>	The Child and Family Agency was established on 1 <sup>st</sup> January 2014 and is responsible for a range of statutory functions including provision of child protection, alternative care, specified regulatory services and a range of family support services. The Agency has commenced a major improvement programme with significant focus on Practice, Culture and Structure.  The Agency currently has responsibility for a budget of circa €1.2billion and delivers its services through over 5,500 people in 259 locations across the Country.  The Child and Family Agency has responsibility for the following range of services:

	<ul style="list-style-type: none"> <li>• Child Protection and Welfare</li> <li>• Parenting, Family Support and Early Help Services</li> <li>• Alternative Care</li> <li>• Birth Information &amp; Tracing and Adoption</li> <li>• Tusla Education Support Services (TESS)</li> <li>• Children's Service Regulation</li> <li>• Counselling and Therapeutic Supports</li> </ul> <p>Further information is available on <a href="http://www.tusla.ie">www.tusla.ie</a></p> <p>NIAPP was established in August 2016 by Tusla and operates within Tusla's Therapeutic Services. NIAPP has a national remit for children in Ireland, aged 3 up to their 18th birthday (at time of referral), who have been accused of having exhibited harmful sexual behaviour, as well as their parents/caregivers.</p> <p>Primary services provided by NIAPP include Consultation, Assessment, Treatment, and Training. The service is provided in partnership on a multi-agency, multi-disciplinary basis in order to encompass the three strands of holistic treatment: child protection, mental health, and criminal justice. As a holistic service, NIAPP aims for the child/young person's sexually problematic/ abusive behaviour to not be compartmentalised from other needs they may have. As such, clinical work while specialized, also aims to meet as many of the child / young person's overall needs including past trauma, mental health, and daily functioning.</p> <p>The person appointed to this NIAPP post will work as part of the specialist multi-disciplinary team delivering clinical treatment services to children, young people and their families; supporting children in the community, in care of Tusla, and in specialist residential treatment programmes. Those with experience of working generally with children and families will likely have the fundamental competencies upon which specialist skills can be built, if not already acquired. Clinical work ranges from basic principles of mental health support/interventions, family communication, systemic therapeutic approaches etc. to complex interventions for nuanced treatment goals which aim to reduce risk of further harm to others and help the children / young people return their lives to a healthier life trajectory. Other aspects of clinical work include clinical formulation, approaches unique to work with younger children, direct work with their parents/carers, structured assessment frameworks (e.g. AIM 3), safety planning and risk management, addressing deliberate self-harm, psychosexual matters, family functioning, and child protection concerns.</p> <p>NIAPP also supports other professionals in their ongoing work with children and young people who have exhibited harmful sexual behaviour and their families. This includes  Delivering ongoing training nationally  Supporting specialist residential centres  Co-ordinating local NIAPP Services throughout the Republic of Ireland. Providing ongoing supervision and training to professionals "released" by Tusla and other agencies to work with NIAPP on a weekly basis (eg for ½ to 1 day per week).</p>
<b>Purpose of Role</b>	<p>The post holder will have responsibility for contributing to the development and maintenance of high standards of professional practice in conjunction with the Principal Psychologist, the NIAPP National Co-Managers, and the NIAPP Team. They will carry out their duties in keeping with NIAPP Operational Guidelines and NIAPP Clinical Guidelines; as well as in keeping with</p>

	<p>Tusla's Policies.</p> <p>The post holder will have a key role in service development and service provision primarily for Tusla South East and the NIAPP services of NIAPP Cork and NIAPP Kerry. These two services operate from ½ day to 1 ½ days per week via small clinical teams released to carry out NIAPP work. The successful candidate will coordinate service delivery for these smaller teams, provide direct clinical work as warranted, train and supervise those professionals released to the local NIAPP service, develop / monitor NIAPP Treatment Plans, liaise with other involved agencies, carry out assessments including psychological evaluations of client group in keeping with NIAPP's Guidelines re Psychometrics; provide monthly reports re enquiries, referrals, waitlists to NIAPP National Co-Management; and producing / supervision of written reports.</p> <p>The post holder will also have a key role on behalf of NIAPP with a Tusla Specialist Residential Programme operated in Limerick. On average, this aspect of the work requires approximately 2 days per week, but not all of that is onsite in Limerick. This role requires weekly provision of direct treatment with all residents (4 bed unit); monthly multi-agency treatment review meetings on behalf of current residents; as well as contributing to recommendations re new referrals to the placement, Group Risk Assessments re how a new placement might impact existing residents, and ongoing communication with the residential team working with each resident. The post holder will be supported in this work by the ongoing involvement of a NIAPP National Co-Manager; who operates as a Specialist Consultant for the residential in coordination with the post holder's role as specialist treatment provider.</p> <p>This post has opportunities to provide training both within Tusla, as well as to other services and Universities. Opportunities to take Trainee Psychologists is always supported; as well as other opportunities for work and training re: working with trauma, working systemically, and other related areas.</p>
<b>Reporting Relationship</b>	You will report to the NIAPP Principal Psychologist.

## **7. Commission for Public Service Appointments – Codes of Practice**

Appointments in Tusla are made under a recruitment license and are subject to Codes of Practice established by the Commission for Public Service Appointments (CPSA). Under the Codes of Practice candidates are entitled to request a review of any part of the appointment process or make a complaint regarding any part of the process that they feel is unfair or has been applied unfairly to them.

Candidates are entitled to one of two forms of review procedure which are mutually exclusive - a Section 7 review **or** a Section 8 complaint. Before submitting a request for review candidates should determine which procedure is appropriate to their particular circumstances.

The procedures allow for matters to be resolved on an informal basis and candidates are advised to avail of the informal process before making use of the formal review procedure.

Informal appeals after interview must be requested within 5 working days of notification of a decision.

### **Please note:**

**A Candidate who is simply seeking clarification on the basis for the decision reached about their candidature should obtain this feedback from the Tusla Recruit Campaign Manager. They do not need to invoke any of the procedures referred to above. Such feedback will be properly managed by the Tusla Recruit Campaign Manager as an integral part of the appointment process.**

- Where s/he has been appointed as a result of that process, s/he shall forfeit that appointment.

## Section 9

Incremental credit may be given on appointment for certain types of relevant previous experience in administrative, allied health professional and associated grades, nursing and non-nursing grades.

### **Social Worker Grades**

Relevant service in public and private social work services is reckonable for incremental service, if it is deemed that role required the candidate to hold the same qualification and the duties and responsibilities are deemed 'like for like'. Job specifications may be referred to for role clarity on verification of service.

### **Social Care Worker Grades**

Relevant service in public and private social care services is reckonable for incremental service, if it is deemed that role required the candidate to hold the same qualification and the duties and responsibilities are deemed 'like for like'. Job specifications may be referred to for role clarity on verification of service.

### **Nursing Grades**

All relevant service in public and private healthcare is reckonable for incremental service.

### **Management/ Administrative Grades**

Incremental credit is granted for all relevant Public/Civil Service (Ireland or abroad). Private Service is not reckonable service for Management/ Administrative Grades.

Relevant public/civil service is reckonable for incremental purposes, if it is deemed that role required the candidate to carry out the same duties and responsibilities (deemed 'like for like') at same or equivalent grade. Job specifications may be referred to for role clarity on verification of service.

### **EWO Grades**

Relevant service in public and private sectors is reckonable for incremental purposes if it is deemed that the previous role required the candidate to hold the same qualifications and the duties and responsibilities are deemed 'like for like'. Job specifications may be referred to for role clarity on verification of service.

Relevant previous experience must be in one of the following areas:

- Youth Work
- Social Care
- Social Work
- Community Development
- School Completion Programme
- Teaching at primary or secondary school level
- Home School Community Liaison
- Garda Diversion Project
- NGO associated with families and children

The onus is on the candidate to claim incremental credit for previous service. Candidates claiming credit for previous service will be required to give comprehensive and accurate information in support of their claim. Credit for previous service will not be awarded until the employing department has satisfactorily completed such measures as it considers appropriate to authenticate the claim.

- All Verification of Service forms received should be stamped and signed by the relevant organisation.
- Where part-time or agency is stated as employment or it is unclear what the weekly hours worked were, confirmation of hours per week should be sought to ensure that they have worked more than 4 hours per week.
- Where it is not clear that the grade and the duties are at the same or equivalent grade a job description should be sought so a comparison of the duties and required qualifications can be made before awarding incremental credit.

- When calculating incremental credit, the dates of service should not overlap.

Part 1:

Obligations Placed on Candidates who participate in The Recruitment Process.
